DOCK:

Charges are for use of dock space only. Dow's Lake Pavilion assumes no responsibility for the loss through fire, theft, collision or other damage to the boat, its occupants or contents. Dow's Lake Pavilion assumes no responsibility for personal injury or death to the owners or renters, their crew, their family or guests anywhere on the marina premises or docks, whether due to the negligence of the marina or otherwise. The above regulations and limitations also apply to the vehicle(s) of the boat owner/renter or his guests. The boat owner/renter agrees to abide by all of the regulations enforced by Dow's Lake Pavilion.

- 1 - Copy or proof of insurance must be provided at time of booking.**
- 2 - All seasonal docking charges must be paid in full by May 15, 2009.** Non payment may result in forfeiture of slip.
- 3 - Docking season starts May 15, 2009.**
- 4 - The season ends Oct 9, 2009. All boats must be removed by that date as water is drained from the lake.**
- 5 - Keep all locking gates closed at all times.**
- 6 - Please be aware that parking anywhere on the ramp, traffic circle or grass is illegal.** You are subject to tickets from the City of Ottawa, The Department of National Defense and the National Capital Commission. Dow's Lake Pavilion does not ticket vehicles.
- 7 - Pass keys and parking permits are the property of 'Dows Lake Marina' and must be returned before departure** or additional charges may apply.
- 8 - Dows Lake Marina will attempt to honor Boat Owner's preference for slip assignment.**
However, consistent with Marina's need to match vessels to slips of an appropriate size.
Dows Lake Marina reserves the right for final decision with slip assignment.
Dows Lake Marina reserves the right to terminate any agreement for berthing facilities or move a vessel without notice.
- 9 - Boat Owners leaving for an extended cruise (more than 24 hours) will so** notify the Marina office. The Marina management reserves the right to rent all boat slips when so vacant without set off against or credit to Boat Owner's Fee obligations under his or her Registration/Boat Mooring Agreement. The Boat Owner agrees to notify Dock Master when he expects to leave and return from a trip of 24 -hour duration or longer so the slip can be used for this purpose and to avoid any inconvenience to Boat Owner upon return.
- 10- For overnight dock users only ("Transient Dockers") dockage day starts at 8:00 a.m.** Any vessel docked prior to 8:00 a.m. will be charged dockage for the previous day. Checkout / departure time shall be 11:00am. Any vessel that occupies a boat slip after 11:00 a.m. shall be charged for the following day.
- 11- Fueling of boats is to take place at the gas dock ONLY.** Fueling of boats at the slip is forbidden and will result in immediate loss of marina privileges, without refund.

IMPORTANT NOTICE TO ALL BOATERS

We do our best to maintain an enjoyable Marina experience for all boaters. From time to time, including most Saturday evenings, there is the likelihood of unwanted sound emanating from our popular pavilion establishments. No refunds or credits will be issued due to noise. If you are a light sleeper, please discuss with a Marina attendant to coordinate an optimum slip assignment.
